Eligibility Criteria for Various posts of IPS Rajasthan Chapter**1. President Elect / Vice President -**

- Applicant should be completed 5+10=15 years after getting Post Graduate or equivalent Degree or Diploma as required to become life Fellow for the society.
- He/She should have a Life fellow number issued / awarded by Indian Psychiatry Society and Indian Psychiatric Society Rajasthan Chapter both.
- He/She has served as Executive Council Member for one term in Indian Psychiatry Society Rajasthan Chapter.
- The President Elect shall serve as Vice-President for one year, then shall hold office as President for one year and shall not be eligible for re-election.

2. General Secretary-

- Applicant should be completed 5+5=10 years after getting Post Graduate or equivalent Degree or Diploma as required to become Life Fellow for the society).
- He/She should have a Life Fellow number issued/ awarded by Indian Psychiatric Society and Indian Psychiatric Society Rajasthan Chapter both.
- He/She has served as Executive Council Member for one term in India Psychiatric Society Rajasthan Chapter.
- Shall hold office for two years If elected by nomination & one year If elected on floor without nomination and shall be eligible for re-election at the end of this period.
- After completion of tenure will serve as immediate past Secretary.

3. Treasurer:

- He/She should have a Life Fellow number Issued/ awarded by Indian Psychiatric Society and Indian Psychiatric Society Rajasthan Chapter both.
- He/She will be holding the office for three years if elected by nomination or one year if elected on floor without nomination and shall be eligible for re-election at the end of this period.
